- ➤ Biodiversity of plant and animal life in the relevant habitats is ensured, maintaining a high level of which is usually considered to be important and desirable.
- > Ecosystem Services are protected to reap the positive benefits that wildlife and ecosystems provide to people. The benefits consist of a wide range of direct, indirect, small, and large.
- ➤ HCV (High Conservation Value) areas are prioritized before expanding the Farmlands or Mill operations. It includes Species Diversity, Landscape-level ecosystem and mosaics, Ecosystem and habitats, Ecosystem services, Community needs, and Cultural Values.
